Dear Mayor Kutteh-Una and Rapid Response Team:

Today, September 15, 2022, we informed our employees that we are consolidating our Statesville facility (at 607 Meacham Rd., Statesville, NC 28677) with our manufacturing facility in Advance, NC. As a result, the Company will permanently discontinue all operations at the Statesville facility on November 15, 2022. We are excited to offer many opportunities for employees to transfer to our Advance facility and hope they will continue employment there.

We'll be meeting with eligible employees again soon to offer details about Advance positions, potential start dates, and busing/shuttle transport we'll provide from Statesville to Advance from November 16, 2022 through January 31, 2023. While we may transfer employees prior to November 15, 2022, those who do not transfer will remain employed in Statesville through that date. While these employees do not have any "bumping" rights, there are many employment opportunities in Advance. In the meantime, we've attached a list of affected positions and the number of individuals in each position.
